

CONSENT TO THE PROCESSING OF PERSONAL DATA

Purposes of Processing

I understand that my Personal Data may be processed for the following purposes:

- receiving, reviewing and responding to my request or enquiry submitted through the Website, including communicating with me regarding my enquiry where necessary;
- routing my enquiry to the appropriate authorised employee or department within Zavod Medsintez;
- where my enquiry relates to a suspected adverse event, side effect, product-quality issue or other product-safety matter — processing it for pharmacovigilance, product-safety and regulatory purposes;
- compliance with applicable pharmaceutical, pharmacovigilance, regulatory and legal requirements.

Personal Data Covered by This Consent

Depending on the information I provide in the form, the Personal Data may include:

- first name and last name;
- job title or professional role;
- email address and, if provided, telephone number;
- my selected user category (for example, Healthcare Professional, Distributor / Partner, Patient or Other);
- the content of my enquiry and other information that I voluntarily provide through the form.

I understand that I should not provide unnecessary sensitive or special-category Personal Data through the form unless it is necessary for Zavod Medsintez to respond to my request.

Health-Related and Special-Category Data

I understand that the general contact form is not intended for the collection of medical information. If I choose the "Patient" category or otherwise voluntarily include in my message information relating to my health, medication use, a suspected adverse event, side effect or other product-safety matter, I understand that such information may constitute sensitive or special-category Personal Data.

In that case, where consent is required by applicable law, I additionally and expressly consent to the processing of such health-related Personal Data by Zavod Medsintez for pharmacovigilance, product-safety, medical and regulatory purposes, including its forwarding to authorised personnel within the medical department of Zavod Medsintez. Access to such information is limited to authorised personnel.

Processing Activities

I understand that processing may include the collection, recording, organisation, storage, use, disclosure where necessary, updating, deletion and destruction of my Personal Data, as well as other processing activities permitted by applicable law. Personal Data may be processed using automated and non-automated means.

Legal Basis and Withdrawal of Consent

Where consent is required by applicable law, this consent constitutes my consent to the processing of my Personal Data for the purposes described above.

I may withdraw my consent at any time by contacting Zavod Medsintez using the contact details provided in the Privacy Notice. Withdrawal of consent does not affect the lawfulness of processing carried out before the withdrawal.

Depending on applicable law and the circumstances of the processing, Zavod Medsintez may continue to process certain Personal Data where another lawful basis for processing applies (for example, compliance with pharmacovigilance, regulatory or other legal obligations).

Retention

My Personal Data will be retained for as long as reasonably necessary to fulfil the purposes for which it was collected, unless a longer retention period is required or permitted by applicable law. In particular, information relating to adverse events, product safety or other regulated matters may be retained for a longer period where required by applicable pharmaceutical or regulatory law.
